

ARTICLES OF INCORPORATION
OF THE
ARJUKEN KARATE ASSOCIATION

KNOW ALL MEN BY THESE PRESENTS

That we, the undersigned all of legal age and residents and citizens of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a non-stock, non-profit corporation under the laws of the Philippines and that end do hereby adopt the Articles of Incorporation.

FIRST. That the name of the said corporation shall be ARJUKEN KARATE ASSOCIATION, Inc.

SECOND. That the purposes and object for which said corporation is formed are as follows: To unite, encourage, promote and disseminate karate in the Philippines, encourage and organize a systematic and standardized physical and mental education in the field of karate, institute, hold, regulate, and support karate tournaments and award various championships envisaged in its athletic calendar, pursue, WWW.LAKB.INFO and research in karate for its continuous progress, conduct karate instruction, exhibitions, seminars, seminars and give a mark of standing to karate members to incite propagation in the Philippines, print or publish in newspapers of general circulation and other forms of information karate activities for its propagation.

As maybe necessary or incidental to the foregoing, to acquire, exchange, repair, install and deal in karate instruments, devices, machines, accessories, adjuncts, parts and materials suitable or convenient for use in connection with any of the things or articles mentioned above or in anyway relating thereto. Profits derived from purposes mentioned above shall be used for the maintenance

and incidental to the above general purposes to acquire, own, improve and maintain real estate and interest therein together with such building, fixtures and equipments as maybe necessary or desirable; to borrow money and to secure the payment of the same by mortgage or lien upon its real estate; and generally to do all and everything lawful and proper which maybe necessary or expedient for the accomplishment of the purposes or the attainment of the objects hereinabove stated or in furtherance thereof.

THIRD. That the principal office or place of business of the corporation shall be located at 747 S. Taylor Boulevard, Omaha.

FOURTH. That the term for which said corporation is to exist is fifty (50) years from and after the date of incorporation.
